With reference to your application dated 20.12.2017 and subsequent the final compliance report dated 31.07.2018 submitted by the School, I am directed to convey sanction for Regular Affiliation to the above said school for Senior School Certificate Examination (Classes XI to XII) w.e.f. **01/04/2018** onwards in the following subjects:-

Core Language : English

Elective Subjects : Physics, Chemistry, Biology, Mathematics, History, Economics, Accountancy, Business Studies, Computer Science, Psychology, Informatics Practice, Physical Education.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of Regular affiliation for secondary classes:-

1. The school will provide additional suitable facilities for classes XI and XII, as per requirements.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
3. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff/4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website: www.cbse.nic.in.

4. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
5. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
6. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
7. It will continue to pay Annual Fee of Rs.5000/- per annum. The schools run by Govt./Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee in CBSE by D.D./Cash in favour of Secretary, CBSE, payable at CBSE, H.Q., Preet Vihar, Delhi-110092.
8. The School had paid an amount of Rs. 26,000/- which has already been deposited in Board's Account vide Board receipt no. 47570 dated 02.01.2018. Out of this Rs. 26,000/- an amount of Rs. 10,000/- has been adjusted as upgradation to +2 stage Fee and Rs. 15,000/- has been adjusted as Annual Affiliation fee for Session 2019-2022@ Rs. 5000/- per annum as the annual fee has been revised from @ Rs.3000/- per annum to Rs.5000/- per annum vide Board Circular no. 01/2018 dated 03.01.2018. The excess received amount of Rs. 1000/- will be adjusted in Annual Affiliation fee from session 2022 onwards.
9. Annual fee has been received upto **31/03/2022**.
10. Special condition to be Compliance by the School within 01 month from the issuing date of this letter.
 1. The School is required to appoint special educator as per Rule No. 13(11) of Affiliation Bye laws of the Board as mentioned in Board Circular dated 25.06.2015.
 2. The School is required to follow the safety guidelines as issued by the Board vide Circular No. 19/2017 dated 12.09.2017 captioned "Safety of Children in schools".
